1 Course Description

This project will focus on consulting. Consulting can be considered a special form of management activity. It can have many different purposes. First of all, it can be used to just provide information on which management decisions can be based. It can also be that specialized expertise needs to be brought into the organisation because it is not available internally. It can also be used to bring a new perspective to the organisation, like innovation or culture change. Usually, there are certain mindsets, strong corporate culture, entrenched ways of thinking in the organisation that block processes of change. Outsiders can bright a fresh new perspective and help managers to take a new look at existing problems or challenges. Consultants can aid management in obtaining certain resources, expanding networks, and through specialist knowledge advice on how to secure the resources. It is safe to say that all business changes, the process, however, is often difficult and experienced by many as painful. A consultant can help to organise the change management needed in the organisation.

A management consultant looks at the strategic processes of an organisation. It can include strategy, sales, marketing or marketing research, business development and finance. It can be about the 'hard' side of the business, like operations management, ICT or other technology, and risk management. Also on the 'soft' side of business like human resources, organisational development, interim management or outsourcing, consulting services are needed.

In this project, the learner will take up the role of a consultant. The learner will need to cooperate and collaborate in a team, work in a project management setting, and do excellent research. The research topic can be acquired by the learners, or provided by the lecturers. It needs to involve a real client with a specific need. It can be in the area of internationalisation, organisational change, market research, business development or policy. The client will need clear advice and be offered the product of research, like a report and be presented the results with a following discussion about the findings. a specified consulting process the project will be carried out.

The comsulting process will follow a particular pattern, like described in the figure below. Even though projects will have different characteristics and timing these phases will always be present.



In this consulting project, we'll apply these stages to help the consulting teams to plan their activities. Although each consulting process will be different we can make use of these stages to steer the project towards a satisfactory result for the client. Throughout the project, we'll monitor the project performance to ensure that the objectives will be met.

2 Place in the Curriculum and Related Courses

This is a fourth-year course that is obligatory for all IBS students. Related courses are: Consulting Skills MIBU-7FCONS-20, Digital Research Skills MIBU-7FDIRS-20 and Business Domain MIBU-7FBDO-20

3 Study Burden

This course is worth **10 EC's.** That means you should be working on this course for 280 hours.

Keep in mind the value you will add to the clients business. Is the work you do valuable and how much would you estimate it will be worth? If you were to present an invoice to the client could you bill the hours you say you have spent on the project to the client? Say you charge 100,- Euro an hour and you have been working in a team of 4. 4 x 100 x 280 is € 112.000,00. Is that the value of your report?

So it is important to have a realistically planned project. Keep your activities attuned to the clients' expectations and make clear what hours spend on the project you would consider billable. You need to show in an Excel file the activities per week per student and the number of hours spent.

Under 12 weekly activities, you can see the weekly workload.
