1. Course Description

The focal point of the course are corporate finance issues within the Treasury Management function. It may serve as an introduction for an assistant treasurer job.

Emphasize will be on the following subjects.

In general: Advising on treasury management issues of companies (corporates, larger SME, evt. listed) and non-profit organizations.

- Understanding Corporate Governance and goals of the firm
- Analyzing the firms' financial position (also in an international perspective)
- Evaluating funding alternatives for investments and M&A
- Analyzing and forecasting balance sheets, profit- & loss accounts and cash flow statements
- Improving and restructuring financial structures of companies
- Building bank relationships, understanding new financial instruments
- Understanding investor relations issues related to equity and bond capital markets
- Using behavioral finance in financial decision making

2 Course Goals and Learning Objectives

Purpose of the course is to extend knowledge and skills to students to succesfully implement treasury management and financing issues. Emphasize is on (strategic) financial analysis, decision making about capital structure, financing instruments like equity and debt, including bank financing as well as (bank)financing issues for non-profit organisations. We will use real life cases and different guestlectures to evaluate and discuss the different subjects in order to make the learning effect as realistic as possible.

3 Place in the Curriculum and Related Courses

This practical course comes with the other minor courses; students should be able to understand balance sheets, profit- & loss accounts and cash flow statements on beforhand.
